## TERMS & CONDITIONS OF SALE

- Terms of Payment: Strictly 30 Days. All overdue accounts will be charged 1½% per month until the outstanding debts/bills have been settled.
- Copyright: We undertake work for our Customers on the understanding that they have legal title to any copyright involved and they shall be liable for any expense arising out of the infringement of copyright should the above not be the case.
- Consequential Loss: Provided that under no circumstances shall CONTELEC ENGRAVINGS LIMITED be liable in any event for consequential loss, special damages or other indirect loss, however arising, whether or not CONTELEC ENGRAVINGS LIMITED knew or ought to have known that such losses or damages might be incurred, including without limitation loss of income, profits, interest or market.
- Cancellation of Order: Any order cancelled for any reason will be charged in full to the Customer.
- Claims: In the case of queries or complaint we must be notified in writing within four days after the date of the Invoice, and all relevant work must be returned together with the invoice and the original material.
- Force Majeure: Every effort will be made to fulfil all orders placed with the Company but the completion of them is subject to variation or cancellation owing to an Act of God, War, Strikes, Fire or any other cause beyond the control of the Company.
- Fixed Terms: No person has authority on behalf of CONTELEC ENGRAVINGS LIMITED to vary any condition except a Director or the Company Secretary, and then only in writing, signed by a Director or the Company Secretary.
- Title: The risk in the goods passes to the Buyer upon delivery but, equitable and beneficial ownership shall remain with CONTELEC ENGRAVINGS LIMITED, until full payment has been received (each order being considered as a whole) or until prior sale of the claim for such proceeds.
- This title shall not be negated by any terms and conditions or standard conditions of purchase issued by the Buyer, however represented, notwithstanding that CONTELEC ENGRAVINGS LIMITED know or ought to have known that these subsequent conditions should have applied.
- It shall be deemed that these Conditions of Sale apply and that the Buyer accepts the same placing his order or orders on CONTELEC ENGRAVINGS LIMITED
- The only exception to this rule is where consent is given in writing by the Directors of CONTELEC ENGRAVINGS LIMITED
